ICE AND AMPHETAMINES EXPOSURE AND USAGE WERE NOT MARGINALISED ACTIVITIES IN AUSTRALIA

Wave 2 of The Cabin's Annual Study Into Australian Knowledge And Attitudes Towards Ice And Other Illicit Drugs (2016) continued to debunk the myth that exposure to and use of Ice and Amphetamines were marginalised activities that largely only impacted the homeless, poor, uneducated, or the mentally sick.

Half of all respondents continued to report that Ice and Amphetamines were not difficult to access by the mainstream community (50% in Wave 2 vs 51% in Wave 1), and 6.7% had tried them (directionally up from 4.9% in Wave 1). In 2016, more than twice the percentage of Australians had trialled Ice or Amphetamines compared to heroin (7% vs 3%). Furthermore, 2.5% were currently using Ice or Amphetamines (significantly higher than 0.9% in Wave 1).

'TRICKLE DOWN' STATISTICS CONFIRMED HIGHLY ADDICTIVE NATURE AND WIDER COMMUNITY IMPACT OF ICE AND AMPHETAMINES

In 2016, 13% of Australians had been offered or had the opportunity to use Ice or Amphetamines, directionally higher than 10% in Wave 1 and more than twice the figure of 6% in the Federal Government's **The National Drug Strategy Household Survey** completed just three years ago.



'TRICKLE DOWN' STATISTICS CONFIRMED HIGHLY ADDICTIVE NATURE AND WIDER COMMUNITY IMPACT ICE AND AMPHETAMINES

In 2016, it was found that one third of people (33%) who had access to Ice and Amphetamines then went on to trialling and 62% of all Ice and Amphetamines triallers were currently or had previously become dependent or addicted to them.¹

Despite the relatively low trial of Ice or Amphetamines when compared to most other illicit drugs, almost two thirds of all Australians (65%) believed that these drugs were the ones most likely to trigger dangerous and destructive behaviour, well ahead of 8% who ranked heroin as the most anti-social drug, and 4% who selected hallucinogens.

When respondents were asked if they believed whether a single trial of an illicit drug could lead to addiction, the top response was also overwhelmingly Ice and Amphetamines; three quarters of people surveyed (74%) believed that Ice addiction could result from one session, followed by heroin (66%), and cocaine (58%).

While the majority of all Australians believed that people addicted to Ice were a danger to the community, the sentiment was significantly higher in regional areas (63% regional vs 54% metro). Similarly, while 19% of metro Australians reported that they had seen the destruction first hand of this drug in their community, this figure significantly increased to 26% for regional Australians.

THERE HAS BEEN A SIGNIFICANT JUMP IN PARENTAL CONCERN ABOUT THE RISK OF ICE AND AMPHETAMINES TO CHILDREN

In Wave 2, over four in ten parents of children aged 5+ (42%) believed that Ice And Amphetamines posed a great risk to their children, representing a significant increase of 75% from Wave 1's figure of 24%. In comparison, the drug identified as posing the second highest level of risk was heroin, with 34% of parents reporting that they viewed this drug as a great risk.

THREE OUT OF FOUR AUSTRALIANS RECALLED BEING EXPOSED TO INFORMATION ABOUT ICE IN THE PAST TWELVE MONTHS

While the percentage of Australians who felt they knew all they needed to about the consequences of Ice for the community was significantly higher in Wave 2 (45% vs 40%), the majority of Australians thought that they still do not know enough.

Wave 2 measured the recall of information about the dangers and impact of Ice in Australia in the past twelve months and found that 73% remembered being exposed to at least one source. The top three cited information sources were the news media (49%), government and community drug education advertising and brochures (27%), and social media (22%). When respondents were asked to rank their information sources by the level of insights they had provided, 62% ranked news media as their top source, 46% ranked government advertising first, and 22% gave social media their top spot.



AUSTRALIANS HAVE STARTED SHIFTING TOWARDS VIEWING REHABILITATION AS A KEY PART OF A COMMUNITY SOLUTION

In Wave 1, an average of \$42 was allocated to education, \$30 to law enforcement, and \$28 to treatment. In Wave 2, while education remained the top choice for investment, there was a significant shift of dollars away from education in favour of treatment. Wave 2 saw an average of \$37 allocated to education, \$31 to law enforcement, and \$32 to treatment.

The increase in the preference for treatment as a way of targeting the problem was consistent with the results of the question 'where do you think Ice addicts belong?'. Seventy percent (70%) of Australians selected rehabilitation, 18% selected jail, and 12% selected other. Even though men were significantly more likely to have selected jail above rehabilitation than women, the majority of men still chose rehabilitation above alternatives (65% vs 75% for women).

Overall, the question of whether the community costs of rehabilitation for Ice addicts were ultimately lower than incarceration was not one that most Australians were confident answering; almost 1 in 2 Australians (43%) were unsure whether they agreed with this statement or not.



BROADER ILLICIT DRUG USAGE AMONGST ICE AND AMPHETAMINES TRIALLERS HIGHLIGHTED GATEWAY DRUG ISSUES¹

Within the sample size limitations of this group, 95% of all Ice or Amphetamines triallers had also trialled at least one of the seven other illicit drugs tested. In fact, the average number of other illicit drugs also trialled by this group was 3.8. The three most common illicit drugs also trialled by this group were cannabis (85%), ecstasy (72%), and cocaine (59%). Heroin was the least likely illicit drug also experimented with, but even this drug had been used by 26% of triallers.

A qualitative overview of the appeal of different treatment options to past and current users (ie those who went beyond using these drugs a few times) found that the two most appealing options were self-focused (cutting back or quitting with their own efforts) while the most unappealing treatment options were those that involved advice and support from external parties (outpatient treatment, inpatient treatment, and seeking advice from a healthcare professional). In this context, it would be helpful to target this at-risk segment with additional information and case studies about all treatment options so as to prompt them to view externally supported treatment programs as more mainstream options that are also available to them.

STUDY OVERVIEW

The Cabin Chiang Mai ('The Cabin') is a leading addiction treatment organisation with inpatient and outpatient facilities located in Australia, Thailand, Singapore, Hong Kong, Malaysia, and The Netherlands. Later in 2016, The Cabin will be launching a new treatment program in Sydney that will be targeting young adults (aged 18-24) with addiction issues.

In May 2015, Maidstone Consulting was commissioned to complete Wave 1 of The Cabin's **Annual Study Into Australian Knowledge And Attitudes Towards Ice And Other Illicit Drugs**. This wave was based on the responses of 1,000 nationally representative Australians aged 18+ who completed an 8 minute online survey.

The objectives of Wave 1 were:

- 1. Identification and testing of Ice Attitudes and Knowledge: What are general Australian attitudes towards Ice and other illicit drugs? What information do they correctly hold, and what areas require debunking or education?
- 2. Identifying the level of parental knowledge and concerns about illicit drugs and their children
- 3. Survey of current and past Ice and amphetamine users so as to humanise the face of addiction

In 2016, The Cabin commissioned Wave 2 of this study with the goal of building on Wave 1's insights into Australian community attitudes towards Ice and other illicit drugs. This new wave also allowed for annual longitudinal tracking of key measures relating to Ice and Amphetamine access, trial and dependency.



STUDY OVERVIEW

Wave 2 was based on 1,053 nationally representative Australians aged 18+ who completed a 7 minute online survey. Wave 2 repeated select core questions from Wave 1 and introduced new areas of exploration. These new areas included exposure to and value of different information sources about Ice, the perceived abilities of different illicit drugs to trigger dangerous and destructive behaviour and to prompt addiction from single use, and an exploration of views relating to the question of rehabilitation vs jail for addicts.

WAVE 2 REPORTING

Study insights were analysed by demographic segments including gender, age groups, parenthood by age of youngest child, state, and location (metro and regional). Sample sizes were provided for each statistic so as to indicate how representative the measure was for particular segments.

Statistical testing was carried out on all intra-segment data within waves (eg 2016 male vs 2016 female, 2016 metro vs 2016 regional, and so on) using a two-tailed 95% significance test. If measures were statistically different to each other, this information was included in subscript information. Corresponding 2015 and 2016 figures were also statistically compared to each other:

ICE AND AMPHETAMINES EXPOSURE AND USAGE WERE NOT MARGINALISED ACTIVITIES IN AUSTRALIA

The Wave 2 study continued to debunk the myth that exposure to and use of Ice and Amphetamines were marginalised activities that largely only impacted the homeless, poor, uneducated, or the mentally sick. Half of all respondents continued to report that Ice and Amphetamines were not difficult to access by the mainstream community (50% vs 51% in Wave 1), 6.7% had tried them (directionally up from 4.9% in Wave 1), and 2.5% were currently using them (significantly higher than 0.9% in Wave 1).

'TRICKLE DOWN' IMPACT OF ICE AND AMPHETAMINES HIGHLIGHTED DANGERS OF EXPOSURE AND TRIAL

Continuing the upward trajectory of the availability of Ice and Amphetamines first measured by the Federal Government's drugs research in 2013 (The National Drug Strategy Household Survey (TNDSHS)¹ and Wave 1 of this study, Wave 2 found that these drugs continued to penetrate the Australian community. In 2016, 13% of Australians had been offered or had opportunity to use Ice or Amphetamines (compared to 10% in Wave 1 and 6% in TNDSHS).

'TRICKLE DOWN' IMPACT OF ICE AND AMPHETAMINES HIGHLIGHTED DANGERS OF EXPOSURE AND TRIAL (CONT)

Mere exposure to these drugs was a worrying finding in itself. This study found that one third of people (33%) who had access to Ice and Amphetamines then went on to trialling. The well-known addictiveness of these drugs was exemplified by the following statistic: 62% of all Ice and Amphetamines triallers were currently or had previously been dependent or addicted to them.¹


SIGNIFICANT COMMUNITY IMPACT BEYOND DRUG USER SEGMENT

¹ Note that this statistic is directional only due to small sample size.

Even for those who were lucky enough not to have been directly impacted by illicit drug use, investigation of the indirect consequences of drugs found that 16% of Australians had been affected by physical and verbal abuse from people they thought to be under the influence of illicit drugs (significantly up from 10% in Wave 1). Thirteen percent (13%) also reported to being the victim of theft, the proceeds of which they believed were allocated to funding drug habits (significantly up from 10% in Wave 1). Over half (57%) felt that people addicted to Ice were a danger to the community and 21% said that they had seen the destruction first hand of this drug in their community. Regional Australians were significantly more likely to feel victimised by the impact of Ice compared to metro Australians.


Know Someone Who Has Tried Ice Or Amphetamines (NET)






Someone Close Was Or Is Currently Dependent On Ice or Amphetamines

















COMMUNITY TRIAL RATES OF ILLICIT DRUGS SHOW ICE HAS NOW SURPASSED HEROIN

Excluding alcohol and nicotine, the most widely trialled drug in Australia was cannabis (32% of the Australian population had tried it at least once), followed by opiates (12%), benzodiazepines (10%), and ecstasy (10%). Seven percent (7%) of Australians had trialled Ice or Amphetamines, more twice the incidence of heroin trialling (3%). Gen Y/Z, Gen X, Non Parents, and people who knew Ice users were significantly more likely to have trialled Ice or Amphetamines than corresponding groups in their segments.

ICE AND AMPHETAMINES WIDELY BELIEVED TO BE THE MOST DESTRUCTIVE AND MOST ADDICTIVE ILLICIT DRUG

Despite the relatively low trial of Ice or Amphetamines when compared to other illicit drugs, almost two thirds of all Australians (65%) believed that these drugs were the ones most likely to trigger dangerous and destructive behaviour, well ahead of 8% who ranked heroin as the most anti-social drug, and 4% who selected hallucinogens.

When respondents were asked if they believed whether a single trial of an illicit drug could lead to addiction, the top response was also overwhelmingly Ice and Amphetamines; three quarters of people surveyed (74%) believed that Ice addiction could result from one trial session, followed by heroin (66%), and cocaine (58%).



THREE OUT OF FOUR AUSTRALIANS RECALLED BEING EXPOSED TO INFORMATION ABOUT ICE IN THE PAST TWELVE MONTHS

in the twelve months to May 2016, 73% of Australians recalled receiving information about the dangers and impact of Ice in Australia. The top three cited information sources were the news media (49%), government and community drug education advertising and brochures (27%), and social media (22%). ... AND THREE OUT OF FOUR AUSTRALIANS SUPPORTED GOVERNMENT POLICY MAKERS TARGETING ICE

Three quarters (73%) of Australians did not believe that the Government was 'scaremongering' with its current focus on lowering the incidence of Ice and Amphetamines supply and usage across Australia. While the percentage of Australians who felt they knew all they needed to about Ice and consequences for the community was significantly higher in Wave 2 (45% vs 40%), the majority of Australians still do not know enough about the drug and its impact.



AUSTRALIANS SUPPORTED EDUCATION AS A KEY COMPONENT OF AN ICE COMMUNITY SOLUTION, BUT THERE WAS A SHIFT TO FURTHER RECOGNISING THE ROLE OF REHABILITATION

The more strategic issue of policy development with the ultimate goal of reducing the take-up of Ice and Amphetamines in the community was explored by asking respondents to allocate \$100 across education, law enforcement and treatment in the way that they thought would best target the problem.

In Wave 1, an average of \$42 was allocated to education, \$30 to law enforcement, and \$28 to treatment. In Wave 2, while education remained the top choice for investment, there was a significant shift of dollars away from education in favour of treatment. Wave 2 saw an average of \$37 allocated to education, \$31 to law enforcement, and \$32 to treatment. The trend was even more notable for groups who had indirect or direct experience with the drugs themselves.

The increase in the preference for treatment as a way of targeting the problem was consistent with the results of the question 'where do you think Ice addicts belong?'. Seventy percent (70%) of Australians selected rehabilitation, 18% selected jail, and 12% selected other. Even though men were significantly more likely to have selected jail above rehabilitation than women, the majority of men still chose rehabilitation above alternatives (65% vs 75% for women).



AUSTRALIANS SUPPORTED EDUCATION AS A KEY COMPONENT OF AN ICE COMMUNITY SOLUTION, BUT THERE WAS A SHIFT TO FURTHER RECOGNISING THE ROLE OF REHABILITATION (CONT)


While Australians were increasingly warming to the idea of treatment and rehabilitation as a part of the solution, they were not certain whether it would be less or more costly to the community than actually placing them in jail. While one third (37%) agreed that the costs to the community of placing addicts in rehab were lower than placing them in jail and 20% disagreed, almost half (43%) were unsure.

Overall, the question of whether the community costs of rehabilitation for Ice addicts were ultimately lower than incarceration was not one that most Australians were confident answering; almost 1 in 2 Australians (43%) were unsure whether they agreed with this statement or not. Constructive community debate that included education around this topic would be a valuable development.

Community Incidence Rates Of Drugs Ever Trialled





Illicit Drugs Ranked First By Perceived Ability to Trigger Dangerous and Destructive Behaviour












Overall, 6% of parents believed that their child trialled Ice And Amphetamines and 2% thought that they had used heroin. However, amongst parents of 18-24 year olds, while only 2% thought that heroin had been trialled, 10% believed that their child had trialled Ice or Amphetamines. Thirty one percent (31%) of parents of 18-24 year olds reported a great level of concern with regards to their child being exposed to Ice while socialising, and 10% held the same level of concern with respect to exposure in their child's work place.







Perceived Drug Risks Impacting Australian Children Aged 5+ in 2015







% Parents Who Believe Child Aged 18-24 Has Experimented With An Illicit Drug (Excluding Alcohol and Nicotine) (NET)





KEY INSIGHTS¹

ICE AND AMPHETAMINES USERS WERE NOT A MARGINALISED POPULATION SEGMENT

In Wave 2's survey of 1,053 Australians, 72 admitted that they had trialled Ice or Amphetamines (7%), and 62% of this group progressed to previously or currently using them more than a few times. While the sample size of 45 users was not robust enough to extrapolate representative quantitative insights about their characteristics, attitudes, and behaviours, this group can be profiled in a qualitative sense.¹

A top line analysis reveals that triallers come from all parts of the Australian community. However, trialling was significantly likely to have occurred amongst Gen Y/Z, Gen X, and Non Parents. One trend that was uncovered by the study was that triallers tended to cluster with other triallers; 76% of all Ice and Amphetamines triallers knew at least one other person who had also trialled the drugs.

BROADER ILLICIT DRUG USAGE AMONGST ICE AND AMPHETAMINES TRIALLERS HIGHLIGHTED GATEWAY DRUG ISSUES

Ninety five percent (95%) of all Ice or Amphetamines triallers had also trialled at least one of the seven other illicit drugs tested. In fact, the average number of other illicit drugs also used by this group was 3.8. The three most common other illicit drugs used by this group were cannabis (85%), ecstasy (72%), and cocaine (59%). Heroin was the least likely illicit drug also experimented with, but even this drug had been used by 26% of this group.

KEY INSIGHTS¹

ATTITUDES TOWARDS TREATMENT OPTIONS

Within the sample size limitations specified to this group, a qualitative overview of the appeal of different treatment options found that the two most appealing options were self-focused (cutting back or quitting with their own efforts) while the most unappealing treatment options were those that involved advice and support from external parties (outpatient treatment, inpatient treatment, and seeking advice from a healthcare professional).


In this context, it would be helpful to target this at-risk segment with information and case studies about all treatment options so as to prompt them to view externally supported treatment programs as more mainstream options that are also available to them.

Incidence Rate Of Ice And Amphetamines Triallers











They are unpredictable and lash out at people. They are also known to steal to support their habits

Because it's highly addictive.... I've seen families torn apart..... It can cause dangerous

behaviou

Taking this drug can make them become violent. Also, once addicted they will do anything to obtain the drug, including theft.

Very horrible drug

Heard so much in the news about it

Break and enters paranoid

Theft, reckless driving

They seem to have no control on what they say or do and can be extremely violent. They seem to have no fear of self-harm. Hence, they'll do what they like when under the influence.

Dependency on ice creates need to acquire the drug at any cost.

Its bad for life cause it ruins your money and health

Because the police focus on marijuana in my community instead of going after the ice

They create a society where young individuals are turned into drug addicts and unemployed vouths.

Have seen it on tv they go crazy

Bad behaviour, they do not know what they are doing, they are desperate for money

They go mental and lose control

It doesn't matter where you go now, you always see someone looking rough, dirty, acting out in very strange ways. Its obvious they are affected by drugs. In areas where there is housing commission, the problem is even more evident. They are dirty, violent and trash their homes. You always see police coming or leaving these areas

Destructive behaviour, leading to crime

The violence.

It is particularly addictive, often results in violent behaviour and the addiction is difficult to cure. Notices in hospitals and public offices warning of violent behaviour is also an indication of the growing problem of ice addiction. However Australia's main problem is and always was ALCOHOL but because of vested interests, little effective measures are taken against its overuse. More effective measures have been taken again nicotine but the government's dependence of taxes on alcohol, tobacco and gambling has turned it into an addicted organisation too. This way you can have high taxation on the entire community without people realising that they are being taxed. Realistic tax rates and pursuit of corporate tax dodgers and overseas tax havens would be more effective and more honest.

From the little I know, it affects their mind and they can become aggressive and behave dangerously

They need it to function, increased crime by allowing more drug dealers

They become very strong and irrational

They aren't in control

I feel that this drug changes the mind set of people and can set them off to be very violent when they lose control. I have seen this a couple of times

Because the drug would have an affect on their behaviour/ make them desperate for money for more drugs - burglarise/ mug etc. (Not an issue I see specifically in my community, but could be a potential issue if their are addicts around)

Those that use it become very violent, aggressive, abusive while coming down from a high, they have no concentration, if they were to drive they could end up killing someone.

Why Ice Addicts Are Seen As Threat To Community

Violence and robbery

Under influence they don't know what they are doing.

Because ice addicts steal from innocent people to help pay for their addiction. They commit violent crimes and do not act like regular people

Violence

I believe that it often causes you to become violent. This can't be good!

You hear of uncontrollable users causing physical harm to their family, emergency personnel and the general public

When on the drug they are not in their right mind & when hanging out for a hit they are very unpredictable.

They have no idea what they are doing

There behaviour is unpredictable

From being one, I am aware of the pull it has. I have now been clean for 6 months

I know what it does . I've seen first hand how it affects families and tears them to bits through lies stealing etc These people are easily irritated, often irrational, violent, prone to extreme mood swings and don't care about anything except their next hit. I have worked with people like this and they were dangerous when they were on them and when they were coming down from the hit

All illicit drugs present a danger to community as it stops one being able to think and act rationally

They make addicts violent they are not in control of themselves

Because they are EXTREMELY violent!!!!!!!!!!!!!!

Because you never know what they are capable of

They obviously lack self control when they are under the influence, and that in itself can be a problem, especially when they are being handled by those who need to restrain them and keep them from being a danger to themselves as well as others.

They have no control over their actions and become extremely violent

They are not aware what they are doing due to addiction

Yes they are violent and unpredictable and breaking and entering a lot more

Unpredictable behaviour. I worry about my employees being addicts and violent at work. I have many blue collar employees in my business

They are out of control

They can be violent, and pose an economic threat as they spend all their money and government allowances on drugs

Crime violence

Cause there judgement to think is impaired

They have no concern for other people - they are only worried about where and how to get their next fix Based on what I have read in the media and seen on news reports

They rob houses to get money. They are violent.

When on ice they do not seem to know what they are doing. They steal to get money to pay for ice Very violent to themselves and others

When on ice, people are out of control and don't know what they are doing. Can be extremely violent. They have no knowledge of what is happening; their ice induced paranoia leads them to do things they would not otherwise do. This drug causes extreme anger and violence.

Because a person may be on ice or they may not be, its a quessing game

They are unpredictable, unstable, and using ice is extremely unhealthy for them in a medical sense. They are prone to assaults and theft due to mental instability brought on by the drug.

They don't care about anyone or themselves so long as they get their fix stopping at nothing to get it Because being aboriginal I've heard stories in my family

They are completely off the planet. Crazy strong and uncontrollable

They frequently are violent

According to TV ads

Great body strength, no fear of anybody, no idea of their actions,

Because they seem to lose all fear of pain, danger and any other consequences of them taking this drug Not sure

Burglary, theft from family or loved ones, caring more about their next hit over all other things & people in their lives

It is addictive. Lots of people will have drug addicts in there town

Because the drug itself causes dangerous side effects to a person that has them lash out at others for their own selfish need for drugs in the first place.

They are not in control of their actions or emotions

I feel that if the ice dependant community increase, the rate of crime and abuse on the streets will. If this happens I will fear for the safety of my family, friends and the general community (including both addicts and non-addicts).

From my limited knowledge it appears ice can change a person's behaviour to being aggressive, non-compliant, dangerous and harmful to him/herself and others.

All drug users are a danger to a community because sooner or later they usually need more money to support their habits

Mainly due to items in the news - I have not been personally involved in any situations involving ice

There's a particular addict I was once friends with who turned on me for no reason. Another girl I know also became a junky and is no longer very capable of looking after her kids.

Users are up predicable and dangerous

The actions are uncontrolled and dangerous

I don't know a lot about how ice affects the individual, however, any drug addiction requires money to fuel it. When money runs out, people can take desperate measures to get drugs and this could be dangerous. Addiction also takes away time and money that parents could use for their children which can result in child abuse and neglect. Furthermore, if an addict owes a dangerous person money for drugs or drugs themselves, these people could very well harm the addict and their families.

The drug puts users in a physical or mental uncontrollable state that they do not know what is right from wrong and hit out at anyone that they know or do not know they become very strong and can overcome a few people at time

They are always angry and strung out. Often walk up my street screaming incoherently & saying they are going to kill someone. Are extremely paranoid and will threaten to hurt you if you as much as glance at them. One threw rocks at every window of my ice-stealing neighbour's flat over debt caused by ice. Previously seen effects of heroin in my area, and ice is 100 times worse. Ice addicts are angry, everyone else is scared.

They are desperate for ice and money to buy it so they steal and are physical towards others

I have seen documentaries on ice addiction

People steal money in order to fund the addiction, they act out when they're addicted

However, no, I don't condone it and see all of these drugs and their pushers/suppliers as extreme threats to society. I'd take them out, put a bounty on them.

Because they are walking aggressive zombies

They have less control over themselves

Once ice has been administered that person is prone to being violent and out of control.

Its dangerous

It's highly addictive and I see on TV and know that they are dangerous on the drug

It can ruin children's or any persons life or lively hood if they get addicted

I am not sure of the facts other than what I have read

Ice is a very serious addiction as documented.

They are violent, untrustworthy and a waste of space

It causes addiction which can lead to behaviour that is negative for the community.

Children are experimenting with these drugs at younger ages...

It affects minds horrendously, this is being played out in the number of armed robberies and attacks on emergency services staff egg. Ambulance and police in Queensland.

Ice changes a person's persona, gives them tremendous strength, they don't know or remember what they have done, it makes then feel like they have crawling insects under their skin and end up with gashes over them, they will pick a fight with anyone who crosses them on the street and if taken to hospital many of the drugs given to them by medical staff do not work on them.

Ice addicts have altered behaviour and can be violent and abusive towards love one and the community

Ice does terrible things in changing your personality and the person who is on ice is likely to do anything and they do not know what they are doing

Addicts can behave unreasonably & sometimes violently

Their unpredictability especially in groups. Disrespect for all law enforcement officers-paramedics etc , their strength while "high" on ice

Violent, strong, unmanageable

I work in child protection and see the damage it causes to families

Because they cannot control themselves when they are on a high, they can't differentiate between what's right and what's wrong, and this leads to impulsive and poor decision choices, often resulting in violence towards their own loved ones and strangers.

There is a large drug ring in our local community and their delivery rounds are getting bigger. Several people I know in the community know someone or are themselves affected. There have been acts of violence, even destruction against any who stand up against the drug lords.

They steal and get violent

They seem to be very aggressive and violent

When under the influence of this drug they are not in their right mind and can be very destructive.

They damage physical health of those that consume it and triggers bad behaviour

There are ice addicts and there are junkies. A junkie will go to extreme lengths to get coin to pay for their drug. It started with theft and has moved to theft from houses or of cars where people are at the property at the time. A junkie does not want to be caught which puts these people at risk if they are seen or disturb the thief. Ice addict have no regard for any type of order and do what they believe is necessary in their situation. They have easy access to weapons including guns and ammunition. These can be easily obtained illegally. As addictions grow so does the crime rate to pay for these addictions.

Because their behaviour is completely out of their control when they are using ice

Dangerous behaviour

Unpredictable behaviour

They seem to become extremely violent, irrational and physically powerful.

From advertisements, media reports and hearsay, it appears well known that people who have immediately/recently taken ice can display psychotic behavioural episodes and be completely irrational and the psychosis (or whatever it induces) can make them extremely volatile and prone to bouts of preternaturally strong violence, often requiring many people to subdue them. Sadly, usually health care workers bear the brunt of it according to media reports etc. But if someone has a psychotic (or whatever the correct term is) episode, say in a shopping centre, medical centre or other public environment, how can the average person defend themselves? What if there are children or elderly people around? This is a frightening prospect which is quite honestly chilling n imagining the repercussions in such a situation. High crime rates , and the fact that they do not care or know what they are doing when on the drug

Unpredictability

They are not in control

From what I have learnt that ice makes most addicts angry besides addictive

Erratic behaviour

Violence

crimes

Aggressive and violent behaviour

This drug turns people from loving caring people into crazed animals if they use it have seen first hand how it happens and it is not just in my community it is all over Adelaide and its suburbs there needs to be something done or our next generation will e addicts

It triggers psychosis

leads to crime

It ruins people

Because of the violence I see portrayed in the hospital ads. There are not enough mental health help options available. I have people addicted in my block of flats who then rage around banging and yelling plus knocking on the door wanting food (no money left) or money

They have no control over themselves. They don't think rationally and will act out in manners violent toward others.

Complete inability to control behaviour

People r out of control under ice

They don't know what they're doing

It generates violence

They are prone to outbursts of rage

People on ice have no control and just lose and it gives them a false sense

It makes people crazy

Violence

Thy become angry and violent when on the drug,

They become violent and they have absolutely no idea of what they are doing and will do anything to get money for next hit

Because they don't know what they are doing when they are on it, they just go berserk.

The increase in their physical abilities (strength) and mental instability is well documented

They appear to attack anyone who gets in their way. Have never heard of a "happy" ice addict.

All seem to be morose and dangerous.

They rob and bash when they are in need

Their unpredictable and violent behaviour. Failure to accept normal conventions. Constant threat to the 'front line' assistance (paramedics, hospital staff police and security).

It makes you violent and paranoid

The violent outbursts the drug appears to cause

On TV adds and media reports have heard how violent addicts cab be

If I understand it correctly ice is one of the drugs that you can become addicted to after one use and as an addict I believe their morals and sense of right and wrong just disappears, leading to a craving that has to be satisfied at any cost

Violence, robberv

Ice induces paranoia to the user and this can cause hallucinations, leading to violence. Addicts will also likely to turn to crime if they are unable to fund over their addiction.

They are violent

Danger to our hospitals & health workers, family & friends of ice addicts

Read about them in magazines on the news.

From what I have seen in the media it seems that ice addicts are more violent, are a huge danger on the roads and have no remorse for the damage they do to themselves, anyone who happens to be in their way. Ice addicts must be gaoled for possession or us and dealers gaoled for a minimum 10 years. The use of ice makes me unwilling to visit central Melbourne after dark

They effect the mind causing antisocial behaviour

Erratic, unprovoked attacks on others, no self-control

Mind is stuffed

All drug users are a danger

Most break ins are being blamed on ice addicts

One can never be sure who is on it so interaction is difficult. They can be quite erratic and violent.



Why Ice Addicts Are Seen As Threat To Community

They are out of control. Do not know what they are doing to themselves or other standby persons.

The ambulance, police and any emergency personnel, stand the chance of being a victim.

Mental harm

They can't control mind

You see a lot of people affected by drugs in my area at certain times in the day

It can lead to violence, theft.

The need for money - the 'I don't care' attitude that is prevalent in the young community today -

their attacks are indiscriminate - the damage that they do to themselves as well

They seem to lose control and become violent, uncaring and unaware of the consequences of their actions.

They become very violent and strong when on this drug and cannot be reasoned with. They become an addict first time and will do anything to get money to continue this terrible addiction Changes their behaviour/demeanour to a violent & angry one, with no quilt for their actions or compassion for the ones they have hurt.

As ice affects the brain, and they are not aware of what they are doing, so can harm you.!

To them self, theft, driving, working

Irrational behaviour.

Violence and angry persons

They lose all reason and will attack their own children and others

They are the danger

Have you seen breaking bad?

They do not know what they are going

If tv ads on the subject are accurate, then it appears that ice addicts are uncontrollable.

People become aggressive towards other people. They steal.

They are out of control and do whatever it takes to partake in their habit

Irrational behaviour, excess strength and people stealing to feed their habit

Just watch the news

Can kill anybody under influence

I have known them. They lose all empathy and understanding. They will steal from anyone, no matter what the relationship was before-hand or how 'nice' they used to be. It dramatically changes people's views of reality to the point where they literally have no feeling for anything or anyone but themselves. My family was nearly destroyed by this drug - mentally, physically and financially.

Ice addicts are destructive, and they can endanger others when they are on a high,

I think they are unpredictable and the drug promotes stronger violence than other drugs

Ice increases anger. It stimulates the brain and pushes people past limitations.

They are totally erratic when on ice

Burglaries & robberies.

Because they become very violent and don't care who they hurt (or worse)

Unpredictable violent behaviour

Once the addicts are high in ice, they could cause physical harm to everyone near them, and they are extremely difficult to tackle due to their increased physical power and lost of sensory.

I think that, because ice is so addictive, and because the users have no idea what they are doing when they are taking ice, and also because they don't know/don't care who they target when they are on the drug, that they become a danger to people in the community.

Violence, robbery, abuse.

They can be unpredictable and violent

They are not in their right mind

It will affect our children

The police have to know where this drug is coming from why are they not stopping my mates son is addicted to this

Have been hearing and reading so much about it lately and all the bad things associated with it

The aggressiveness during their withdrawal causes them to inflict violence, cause major damage, and steal

Burglary aggression becoming more easily attainable

They seem to lose control of themselves and are forgetful cruel

I think ice may make people violent. Addiction to any drugs usually means that the person is desperate for money and this might lead to an increase in burglary/street robbery

Its can make people react very violently, more so than other drugs.

Violent erratic behaviour

When they are high, they can be totally out of control

When they use and are out with the general public they are putting themselves and us in danger

Their mind goes warped and it makes it hard to make correct decisions

I was in hospital emergency recently and observed 2 ice druggies threaten doctors and nursing staff. Bloody frightening.

Why Ice Addicts Are Seen As Threat To Community

Anti-social and violent behaviour

Theft, money to get their next hit

Scared they are unpredictable, very strong, hard to control

The government is a joke and self serving

have seen vision on the television of people affected by ice 'flipping out' violently in hospital emergency rooms, I imagine hospital workers are at particular risk....I also read the newspaper stories which indicate that persons under the influence of Ice can became very violent, which would endanger members of the community.

Because they go crazy when hey are high or coming down from a high

Desire for the drug could lead to increase in crime especially theft

Increased rate of theft. Difficult to get off addiction. Meth labs explode. Dangerous and uncontrollable behaviour when you're on meth.

This drug is out of control in some areas

They are so high they don't know what they are doing I have seen first hand how terrible it is and how the people have been bashed or even raped

Ice addicts lose all control and thieve to support there habit

Because they can not control their addiction and behave erratically in all situations whether drugged up or trying to get drugged up

From news reports, there seems to be a lot of cases of dangerous behaviour from people after using the drug ice. Because the drug often makes people very violent.

Violent antisocial behaviour

Dangerous when under the influence

The drug controls their behaviour and makes them do things they wouldn't normally do

Danger to themselves it sparks violent outrages, hallucination's

Because they are so unpredictable in their temper. They can't function properly. It is so hard to get off ice & takes so long, many just stay on the drug as they can't get help. This then leads to more robberies & violent behaviour. It is a real worry when there is children involved which then brings in another factor. The children will have to be taken away & cared for by other people. It all puts a huge strain on the system in so many areas.

Its dangerous

Here stories of ice users raging

Very psychotic

Users of the drug are violent and lash out blindly towards loved ones and strangers and have no mental capacity to make sound judgement because there mental state is no longer able to process right from wrong.

Erratic behaviour, crime to fund addition

What you hear on the news

Their aggressiveness

They are starting to commit robberies in towns close to us, and I don't like having to deal with them in the city streets.

They are not in control of themselves

Violence

Because they will rob and steal from you and sometimes harm you or kill you to get their fix of ice

Their behaviour is a danger to themselves and others

Drug affected, violent, out of control

While using methamphetamine, users can feel hypersexual and uninhibited, often forgetting to use protection. Ice causes extreme paranoia and violent rages

Ice stimulates the user to serious aggression, way beyond reason. As a nurse I've encountered people affected by this and other drugs in the ED, and have known of instances where those trying to help have been attacked.

I believe that people addicted would do anything for the drug ice, including various crimes

They can become very aggressive

Threatens safety

Because they are in need of there highland the drug can cause psychotic episodes

I know that the proportion of ice users is very small compared to say the problem caused by alcohol and that alcohol is the primary danger in our community for so many reasons. Ice is of concern because of the extreme reactions/behaviours of people affected by ICE an that is the only reason for this observation. I do not view ICE as THE primary danger by any means.

I only know what I've seen on the news. Seen on news people going crazy and being violent and not in control of themselves

Don't have any control over what they're doing

Because it seem to turn them into "super" beings and cause destruction to people and property

Violence being on the increase

They do not realise what they are doing when they are under the influence of the drug and can cause harm to other people, themselves and property

Because they become addicted very quickly and cannot afford to pay for their needs, so they steal from soft targets to get cash/goods to use for ice.

Thru robbery and domestic violence

Robberies, violence in streets

Violence, physical abuse and act of violence

Their behaviour is unpredictable, they might be ok one minute and explode the next. The don't feel the pain so will continue doing something despite hurting themselves, eg hitting a wall even though their hand is bleeding and raw. It affects their mental state so they can no longer think straight. They steal, break into houses/cars/offices. They have no sense of right and wrong



Why Ice Addicts Are Seen As Threat To Community

They see and hear things that aren't there. Want to harm other people. Just makes them unpredictable and causes mental issues. Will rob/attack people for money to supply there habit'

People do not know the impact it has on people when using long term, powerful drug etc

From what I see in the media they are out of control and dangerous in the extreme

They will do anything to get the money to get their next fix

Don't know what they are doing

They tend to be violent.

Should legalise it let them kill themselves and problem solved wasting time money on resources on people that cant help themselves is a waste when it could be better spent elsewhere

It seems to have such an instant addiction effect and a much more severe withdrawal effect than what we here about other drugs such as heroin, cocaine and the like and as there are a lot of seniors in the suburb where I live and in the surrounding area the antisocial effects will be more readily noticed

Strongly addictive and while under the influence crimes are likely to occur

From the information I've seen in the media, the drug is very addictive and can really mess with peoples heads.

The lack of real consequences for criminals in our community

Uncontrollably violent

They seem to be particularly aggressive and out of control

They steal and rob to get money for their drugs.

Impossible to handle. Lie cheat and steal. Erupt at the slightest provocation.

Under its influence people behave differently and can be dangerous

They take the drug and somehow their mind snaps and they go crazy. They become extremely violent and it doesn't matter to them who they vent their violence upon.

The extreme depression that comes after an ice high can be volatile.

Because they can get a drug induced psychosis from taking them and harm themselves and or others They are very aggressive to ambulance and people in general

The information available is explicit in facts, hospitals are information that shows the results of addict react. It puts nurses, doctors, police etc in great danger! Most importantly the person is damaged for a long time.

I am not sure but I think it makes your brain not function correctly

My main concerns stem from media reports about police, medical staff and family members who have been attacked by people affected by ice.

Damage that have taken place as reported in the media

They are usually very violent.

It is everywhere

Get aggressive

They neither care what they do to others

Violence and robberies.

From reports in the news print and television and radio.

They go into a another world and become dangerous to them selves and others.

Lose all sense of reality. Will commit crime and violence to obtain drug

Because they can still drive a vehicle and kill people

They commit crimes to pay for their addiction

Become crazy and do harmful things to people and property

They go crazy

They may be pushed to criminal activities to fund their addiction.

The personal safety of my family and I is at risk from ice addicts

As a result of being on ice

Because they become very violent

Become addicts and resort to stealing or even mugging people to get money to pay for their habit.

Become unpredictable and violent.

They rob, abuse and are a medical burden.

Ice user develop bizarre, destructive aggressive or violent behaviour. And that is unacceptable in the community

Uncontrolled violence. Burglary, Muggings, A danger to those trying to help them (medics, police)

They become aggressive and unpredictable

They become very aggressive even psychotic and aren't aware of their actions

Its everywhere

They get off their heads and then violent

I believe their addiction is much more serious than other addictive drugs and the pressures to consume ice drive people to commit serious crime particular when the street cost of the drugs increase due to demand and supply

They are just so out of control and gain super human strength

My children are all grown up and its harder because your not around them all the time any more to known what there up to 'you just hope they make good healthy choices

She has just become a mother & I don't think she has any time for drugs

Mental disorder, dangerous self & others

Addiction and crime

We know our son has tried cannabis but appears to have just been a flirtation although concerned that having done it a couple of times he is in a circle of friends where he probably can get access so going back to it is a concern. Then the long term never/brain damage is the other concern

Over dose and addiction

Genetic and emotional history

That they will be attacked by somebody who is taking it or have a substance put in their food or drink because these people think it is funny to do that That they attempt them in the first place, and then become addicted. Every other concern is a consequence of these 2

Not being able to stop

Kids these days are easily led. ICE is a drug that in the ice circles is there society if your in that circle your an addict excepted for what you are.

Because they will take the drug and get addicted to it and they will have a likely chance of dying

That they get in to deep and become addicted

There is none for me. I have talked to my children and they both have such strong opinions about drugs and alcohol. Neither of them are interested and freely talk to me about lots of subjects in life.

I fear they may have their drinks spiked

Child trying drugs due to peer pressure, as well as curiosity to try new things.

Peer pressure other peoples influence social groups

I would prefer my child to be kept away from people who do it!! But it is rather difficult

I am concerned about some of my son's friends and their recreational activities. They say that they respect my son's wishes to be 'clean' and not use any substances at all but I am concerned that they may decide to spike his water (don't laugh, that's all he drinks, not even tea or coffee) just to see what happens to him. I am also concerned that if my son is out with his friends and they are using that he will somehow be caught up in any mess that follows.

Why they are taking it

Forming an addiction and the adverse effect that this would their ability live fruitful and rewarding lives and the impact all who love them

They are always looking for some sort of excitement

The concern isn't her she knows what's wrong or right my daughters dot smoke either but its the friends they keep and who they might meet around the corner who might influence them in the long run that's the concern I have but its not with them but the situation

Being offered and pushed into trying.

My greatest concern in regards to drugs and my child is someone forcing them on him because I know how he feels about drugs and the people who take them. For him to take them it would be against his will

Bad news

They could get hooked

He gets mixed with wrong crowd, peer pressure

Concerned will not separate from friends that delve into that lifestyle and is easily swayed to follow their lead

Poison can kill them

Possible addiction, messing with the wrong crowd

My child wouldn't try drugs

There dangerous

Friend influences

"Pressured into taking them

Adverse reactions to taking them"

Death

That someone will pressure them into trying something, and they have a bad reaction or something happens to them while under the influence. Or that someone might slip something into their drink without them knowing, and something happens to my child

I see parents of 22year old kids wasted and stinking of booze and cigarettes in the Centrelink offices. What gives? I think it was easier to raise my kids in the USA as far as drugs go, at least.. It's very trendy here, but old hat there. I don't know. I'd crack down like the black plague on all of it.

That they would et addicted ruin their lives and their bodies and end up as useless, homeless druggies

Access to it, it being present in schools and uni.

Hiding drugs from me and there behaviour

Addiction

That they think once won't hurt. Addiction runs on both so des I f family

I don't have any concerns as she has never had any interest in taking drugs but has been very supportive to friends/relatives who struggle with addiction

People pushing it on to them

They get hooked and I cant help them

Not sure if they would be willing to use and fear of being more open to peers than to me.

Based on the probability of events it is possible that at some gatherings of young people someone who uses/possesses drugs might be present and may talk about them

If someone slips one of them in her drink. Or someone on ice injecting her. To get what they want.

Being pressured by his peers

Just seems to be everywhere

Get addicted

Temptation to try

As for any parent addiction and possible loss of life for my child/ children

Peer group pressure

I have no concerns - they have been raised correctly

To become addicted which would ruin their life.

My daughter is a haemophiliac and has always been told that under no circumstances is she to take any illicit drugs as she can fall and kill herself or do herself severe damage that could have a very detrimental affect on the rest of her life and she has only once at 18yrs at a graduation party tried a joint she didn't like it and so has never tried anything else how do I know we have a great relationship and I'm her carer and she doesn't leave the house without me 24/7 so yes I'm sure Not knowing how strong they can be, not knowing what to do if something goes wrong, not knowing how much to take

He's already affected family relationships because of his drug dependence and his health has been greatly affected I'm very concerned for his well being Personal safety

Child is in a intoxicated situation and then is asked to try some of the illicit drugs.

Trying liking and getting addicted once they do they are on their own as I will do nothing to stop them they are old enough to make their own decision vote drink etc then they make their own choices

Peer pressure

They go out with friends to different events and I know that these events are targets for drug dealers and I'm afraid that they might be tempted or have a drink spiked.

I have no concerns relating to curiosity
